For use over existing multi-layered painted surfaces to reduce the spread of flame in the event of a fire.

application details

Method of application	discolouration. Apply 1 coat by short / medium pile roller.
Mix ratio	Base and activator supplied in correct proportions. Add all activator to base container. Mix thoroughly for at least 5 mins until product is smooth and even. Allow to rest 5 mins before using. DO NOT MIX PART UNITS. Badly activated or incorrectly mixed materials will affect performance and may cause early failure or

surface preparation

Only for use on well adhered painted surfaces.

Scrape off any loose or flaking paint back to a firm edge.

Remove existing graffiti with Torclean Graffiti Remover Wipe System or Torclean G Graffiti Remover.

Wash down and degrease using Torstrip WDA10 Wash Down Agent diluted 1:10 with water. Rinse with clean water.

Ensure surface is clean, dry and free of contamination prior to paint application.

limitations

Will only achieved fire upgrading properties if applied as part of the Torrex AG or Torrex Eggshell Systems.

Torrex Fire Upgrading Systems can only be applied over previously painted surfaces which show good adhesion, both between coats and to the original surface.

Adhesion checks must be carried out before specification of the system.

Do not apply and/or allow to dry at temperatures below 5°C.

Do not apply if condensation is likely to occur.

Only applied at 8 sq.m / litre when used with Torrex AG-X topcoat – refer to specification.

safety precautions

A copy of the appropriate Health & Safety Data Sheet should be consulted prior to using the product. This can be faxed if urgently required.

Minimum precautions for all paints:

- 1. Avoid skin and eye contact i.e. wear gloves, goggles, etc.
- 2. Ensure good ventilation, mechanical if necessary.
- 3. Store and use away from heat and flame.
- 4. Do not eat or smoke in the vicinity of work.
- 5. Wash hands before eating.
- 6. Refer to supply container for additional warning labels.
